In continuation to our newspaper advertisement dated 21th August, 2025, Notice is hereby given that 18th AGM of Members of Bhilwara Technical Textiles Limited ("the Company") will be held on Thursday, 18th day of September, 2025, at 2:00 p.m. through Video Conferencing/Other Audio-Visual Means ("VC/OAVM") in compliance with provisions of the Companies Act, 2013, rules framed thereunder, SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, read with Circular(s) issued by Ministry of Corporate Affairs or SEBI in this regard, to transact the Ordinary and Special Businesses as set out in the Notice of 18th AGM without the physical presence of the members at a common venue. The venue of the AGM shall be deemed to be Registered Office of the Company.

Notice of 18th AGM and the Annual Report of the Company for the financial year 2024-25, have been sent on Tuesday, 26th August, 2025, through electronic mode to the members of the Company who are holding shares as on Friday, 22th August, 2025 and whose email addresses are registered with the Company /Depository Participant(s). Members holding shares either in physical form or in dematerialization form, as on the cut-off date for e-voting i.e. Friday, 12th September, 2025, may cast their vote electronically through electronic voting system ("Remote e-voting") provided by National Securities Depository Limited ("NSDL"). All members informed that:

- The Ordinary and Special Businesses, as set out in the Notice of 18th AGM, will be transacted through voting by electronic means;
- The remote e-voting shall commence on Monday, 15th September, 2025 at 9:00AM (IST); and end on Wednesday, 17th September, 2025 at 5:00 PM (IST);
- The cut-off date is Friday, 12* September, 2025 for determining the eligibility to vote through e-voting or through the e-voting system during 18* AGM;
- v) Members may note that: a) the remote e-voting module shall be disabled after the aforesaid date and time for voting and once the vote on a resolution is cast by the Member, the Member shall not be allowed to change it subsequently; b) the Members who have cast their vote by remote e-voting prior to the date of 18th AGM may participate in 18th AGM through VC/OAVM facility but shall not be entitled to cast their vote again through the e-voting system during 18th AGM; c) the Member participating in 18th AGM and who had not cast their vote by remote e-voting, shall be entitled to cast their vote through e-voting system during 18th AGM; and d) a person whose name is recorded in the Register of Members or in the Register of Beneficial Owners maintained by the depositories as on the cut-off date for e-voting only shall be entitled to avail the facility of remote e-voting, participating in 18th AGM through VC/OAVM Facility and e-voting during 18th AGM.
